To designate additional river segments in the Angeles and San Bernardino National Forests in the State of California as wild and scenic rivers, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “_____ Act
5 of 2014”.

1 **SEC. 2. DESIGNATION OF ADDITIONAL RIVER SEGMENTS IN**
2 **THE STATE OF CALIFORNIA AS WILD AND**
3 **SCENIC RIVERS.**

4 Section 3(a) of the Wild and Scenic Rivers Act (16
5 U.S.C. 1274(a)) is amended by adding at the end the fol-
6 lowing:

7 “(____) EAST FORK SAN GABRIEL RIVER, CALI-
8 FORNIA.—The following segments of the East Fork San
9 Gabriel River, to be administered by the Secretary of Agri-
10 culture in the following classes:

11 “(A) The 10-mile segment from the confluence
12 of the Prairie Fork and Vincent Gulch to 100 yards
13 upstream of the Heaton Flats trailhead and day use
14 area, as a wild river.

15 “(B) The 2.7-mile segment from 100 yards up-
16 stream of the Heaton Flats trailhead and day use
17 area to 100 yards upstream of the confluence with
18 Williams Canyon, as a recreational river.

19 “(____) NORTH FORK SAN GABRIEL RIVER, CALI-
20 FORNIA.—The 4.3-mile segment of the North Fork San
21 Gabriel River from the confluence with Cloudburst Canyon
22 to the .25 miles upstream of confluence with the West
23 Fork San Gabriel River, to be administered by the Sec-
24 retary of Agriculture as a recreational river.

25 “(____) WEST FORK SAN GABRIEL RIVER, CALI-
26 FORNIA.—The following segments of the West Fork San

1 Gabriel River, to be administered by the Secretary of Agri-
2 culture in the following classes:

3 “(A) The 6.7-mile segment from .25 miles
4 downstream of its source near Red Box Gap in sec-
5 tion 14, T2N, R12W to the confluence with the
6 unnamed tributary one quarter mile downstream of
7 the power lines in section 22, T2N, R11W, as a rec-
8 reational river.

9 “(B) The 1.6-mile segment of the West Fork
10 from one quarter mile downstream of the powerlines
11 in section 22, T2N, R11W to the confluence with
12 Bobcat Canyon, as a wild river.

13 “(____) SAN ANTONIO CREEK, CALIFORNIA.—The
14 1-mile segment of San Antonio Creek from its source near
15 Mount Harwood in section 5, T2N, R7E to San Antonio
16 Falls, to be administered by the Secretary of Agriculture
17 as a wild river, except that the Secretary of Agriculture
18 may permit the continued operation within the segment
19 of the historic San Antonio ski hut.

20 “(____) MIDDLE FORK LYTLE CREEK, CALI-
21 FORNIA.—The following segments of the Middle Fork
22 Lytle Creek, to be administered by the Secretary of Agri-
23 culture in the following classes:

24 “(A) The 4.3-mile segment from its source near
25 Cucamonga Peak in section 26, T2N, R7E to the

1 eastern boundary of section 19, T2N, R6E, as a
2 wild river.

3 “(B) The 1.2-mile segment from the eastern
4 boundary of section 19, T2N, R6E to the eastern
5 boundary of section 20, T2N, R6E, as a recreational
6 river.

7 “(____) LITTLE ROCK CREEK, CALIFORNIA.—The
8 following segments of Little Rock Creek and tributaries,
9 to be administered by the Secretary of Agriculture in the
10 following classes:

11 “(A) The 10.3-mile segment from its source on
12 Mt. Williamson in section 6, T3N, R9W to 100
13 yards upstream of the confluence with the South
14 Fork Little Rock Creek, as a wild river.

15 “(B) The 6.6-mile segment from 100 yards up-
16 stream of the confluence with the South Fork Little
17 Rock Creek to the confluence with Santiago Canyon,
18 as a recreational river.

19 “(C) The 1-mile segment of Cooper Canyon
20 Creek from .25 miles downstream of Highway 2 to
21 100 yards downstream of Cooper Canyon Camp-
22 ground, as a scenic river.

23 “(D) The 1.3-mile segment of Cooper Canyon
24 Creek from 100 yards downstream of Cooper Can-

1 yon Campground to the confluence with Little Rock
2 Creek, as a wild river.

3 “(E) The 1-mile segment of Buckhorn Creek
4 from 100 yards downstream of the Buckhorn Camp-
5 ground to its confluence with Cooper Canyon Creek,
6 as a wild river.”.
